

Creative Player Soccer Complex - FACILITY PARTY AGREEMENT

PAYMENT: \$200 Non-Refundable deposit/ payment due at time of reservation.

CANCELLATION: Full refund will be given if cancellation is done prior to 14days before event, no refunds will be given thereafter.

A rental at Goal Sports dba Creative Player Soccer Complex constitutes use of the indoor and outdoor fields, party room, restrooms, and viewing area of the facility during the written rental time. Facility located at 2601 Wilkinson Blvd, Charlotte, NC 28208. Any use of the facilities before or after the rental time will result in additional fees charged in increments of 30 minutes. Rental includes up to 20 players on the field. Additional players will be charged \$5.00 each. The undersigned rental party agrees to abide by all of Creative Player Sports Complex rules. At no time shall the undersigned or the rental group deviate from the accepted rules. The undersigned accepts all responsibility for all persons and property during the written rental time. Owner warrants that the Property shall be provided at the inception of this Agreement to User in clean and fully functional order. Should the Property, upon termination of this Agreement, be returned to Owner in any less clean or functional condition (excepting normal wear and tear), User shall be assessed a cleaning fee of \$25.00 per hour, plus costs of maintenance, repair and damages, if any, unless arising as a direct result of Owner's act or omission.

Facility Rules: User and User's participants, employees and other third parties (other than the Owner), who may enter the Facility or the Property during the Rental Period, agree to abide by the rules of the Facility. All User's participants likely to engage in physical activities at the Facility will sign the Facility's Waiver Form.

Indemnification. The User assumes and agrees to be fully and exclusively responsible for the safety of the persons and property of all participants in the events during the Rental Period, including, without limitation, employees, participants, associates, guests, spectators and any members of the public in attendance at any of the events being held by the User at the facility. The User shall defend, indemnify, and hold the Owner, its officers, employees, and agents harmless from and against any and all liability, loss, expense, including reasonable attorneys' fees, or claims for injury or damages arising out of the performance of this Agreement but only in proportion to and to the extent such liability, loss, expense, attorneys' fees, or claims for injury or damages are caused by or result from the negligent or intentional acts or omissions of the User, its officers, agents, employees, participants, associates, guests, spectators and any members of the public in attendance at any of the events being held by the User at the facility.

In addition, the following rules shall be in effect: 1. All persons participating in any activity shall have a current Creative Player Waiver Form signed. 2. All persons participating in soccer games must wear protective shin guards. 3. No outside food or beverages or gum are allowed inside the turf fields. 4. Outside food and beverages are allowed in party room. 5. Please arrive 15 minutes before your written rental time and be prepared to vacate the field promptly as others may be waiting for field usage. 6. Referees/Field supervision are available at additional charges, and must be approved in advance. 7. No cleats are permitted inside the field – turf shoes, indoor soccer shoes, or regular tennis shoes only.
