### 10's - 14's Elite and Premier Parent & Player Contract

-- PLEASE TAKE TIME TO READ THIS IMPORTANT DOCUMENT--

**This is your contract with Wildcat Jrs. VBC for the 2018-2019 club season.**

Your dues cover the club's expenses for practices, equipment, coaches, all tournament entry fees, AAU Membership and administrative expenses.

Other additional costs would include coach's expenses for travel, room and board on overnight tournaments.

#### **PAYMENT SCHEDULE DUE DATES:**

**1<sup>st</sup> Payment:** \$1200 for 14 Elite, \$1020.00 for 13 Elite, \$600 for 12's, 13's & 14's Premier players, \$525.00 for 10's/11's players; Due on October 18<sup>th</sup>, 2018.

**2<sup>nd</sup> Payment:** \$1150.00 for 14 Elite, \$1000.00 for 13 Elite, \$1200 for 12 Elite, \$860 for 12's, 13's & 14's Premier, \$500 for 10's/11's players; Due: February 1<sup>st</sup>, 2019.

Payments can be made by credit card through your online account or by check.

Checks can be made payable to Wildcat Jrs. Inc.

Wildcat Jrs. VBC - - PARENT/PLAYER CONTRACT

The 1st payment is due at the Parent Night Meeting on October 18<sup>th</sup>, 2018.

**Dues must be paid before any player will be allowed to begin practicing.**

Second dues installments are due February 1, 2019.

Please note, Wildcat Jrs. is required to pay in advance items such as facilities, memberships for players, teams, and coaches, tournament entries, etc., thus the timeliness of your payments are important and very necessary.

Travel expense payments must be submitted on or before their specified dates. Deadline dates will be made available separately.

**Players will not be eligible to compete unless special event expenses are paid.**

**IMPORTANT COMMITMENTS REGARDING THIS CONTRACT**

- a. Failure to pay your dues or any other expenses to Wildcat Jrs. VBC on the specified dates will result in the removal of the player from future competition events until the account is up to date or other payment arrangements have been made.
- b. Failure to pay trip deposits and balances due to Wildcat Jrs. VBC on the specified dates will result in the removal of the player from future competition events until the account is up to date.
- c. There are "NO REFUNDS". No Refunds shall be given for dues, deposits, special event expenses, equipment, etc.

**Once you have signed this contract** you are financially committed & responsible for the **full amount** of the yearly dues and any balance on your account, **whether or not you complete one day or the full season.**

**By signing this contract**, you are **committing** to the **full payment** of all dues, travel payments, and additional expenses charged to you, whether you complete the season or not. Wildcat Jrs. VBC reserves the right to pursue any member through legal proceedings for non-payment of dues or any other non-payment of expenses owed to Wildcat Jrs. VBC. In addition, the expenses of the attorneys and court costs incurred by Wildcat Jrs. VBC will be included. **By signing this contract**, I, the member's parent or guardian, **confirm that I have read, understand, and agree** to all the conditions of this contract entered into with Wildcat Jrs. VBC and **that all information I have submitted is accurate and correct.**
