+ Travel fees for MidEast Qualifier, and AAUs. Mandatory for all players regardless of whether or not you attend.

Payments can be made by credit card through your online account or by check.

Checks can be made payable to Wildcat Jrs. Inc.

The 2nd payment is due at the Parent Night Meeting on October 24, 2019. Dues must be paid before any player will be allowed to begin practicing. Third dues installments are due February 1, 2020. Please note, Wildcat Jrs. is required to pay in advance items such as facilities, memberships for players, teams, and coaches, tournament entries, etc., thus the timeliness of your payments are important and very necessary. Travel fee payments must be submitted on or before specified dates. Deadline dates will be made available separately.

Players will not be eligible to compete unless special event expenses are paid.

IMPORTANT COMMITMENTS REGARDING THIS CONTRACT

- a. Failure to pay your dues or any other expenses to Wildcat Jrs. VBC on the specified dates will result in the removal of the player from future competition events until the account is up to date or other payment arrangements have been made.
- b. Failure to pay trip deposits and balances due to Wildcat Jrs. VBC on the specified dates will result in the removal of the player from future competition events until the account is up to date.
- c. There are “NO REFUNDS”. No Refunds shall be given for dues, deposits, special event expenses, equipment, etc.

Once you have signed this contract you are financially committed & responsible for the full amount of the yearly dues and any balance on your account, whether or not you complete one day or the full season.

By signing this contract, you are committing to the full payment of all dues and travel payments charged to you, whether you complete the season or not. Wildcat Jrs. VBC reserves the right to pursue any member through legal proceedings for non-payment of dues or any other non-payment of expenses owed to Wildcat Jrs. VBC. In addition, the expenses of the attorneys and court costs incurred by Wildcat Jrs. VBC will be included.
