 Facility (Entire) - \$150 /hour

 2.) 4 - hitting tunnels w/ L-Screens including four buckets of balls and hitting tees)  
 3.) 2- portable pitching mounds  
 Classroom rental - \$100 /hour Includes - table, chairs, classroom setting w/ whiteboard, video analysis capabilities

**HOLD HARMLESS AND INDEMNIFICATION AGREEMENT**

CONTRACTOR agrees to defend, indemnify and hold harmless Norcal Mavericks Athletic Development, its officers, agents and employees (collectively referred to hereinafter as "NMAD") from and against any and all claims, demands, causes of action, or liabilities incurred by NMAD arising, in whole or in part, directly or indirectly, from Contractor's acts or omissions under this Agreement or any act of omission of Contractor's officers, agents, employees, contractors, or persons attending the Meeting or Event with the express or implied permission or invitation of Contractor, except as may arise from the gross negligence or willful misconduct of NMAD. In any action or claim against NMAD in which Applicant is defending NMAD, NMAD shall have the right to approve legal counsel providing NMAD's defense and such approval shall not be unreasonably withheld.

**HOLD HARMLESS AND INDEMNIFICATION AGREEMENT CONTINUED**

Contractor further agrees to release NMAD from any and all claims for any damages, including property damage, injury or death occurring or arising out of use of NMAD's property, except as may be caused by the NMAD's gross negligence or willful misconduct. Contractor agrees to abide by the Facility Use Rules and Regulations and acknowledges having received a copy thereof. Further, Applicant will be held financially responsible for any damage to the Facility or equipment, which occurs through Contractor's Meeting or Event at the Facility. Furthermore, Contractor has reviewed and agrees to abide by the NMAD of Chico rules and regulations pertaining to the use of the facility. Contractor understands further that Contractor will be held financially responsible for any damages to facilities or equipment that occurs through the use of the Facility.

**Insurance Requirement:** At least five days prior to the use of facilities, organizations must submit to NorCal Mavericks Athletic Development an insurance certificate with combined single limits of \$100,000 and an additional insured endorsement naming the Norcal Mavericks Athletic Development. The insurance certificate provided by organization pursuant to this agreement must also state that this insurance shall be primary to any insurance purchased or owned by the Norcal Mavericks Athletic Development. Norcal Mavericks Athletic Development will not provide setups, services or facilities until required insurance is provided.
