Participation Waiver regarding COVID-19

The COVID-19 global pandemic has presented athletics across the world with a myriad of challenges. The COVID-19 virus is a highly contagious illness that primarily attacks the upper respiratory system. The virus that causes COVID-19 can infect people of all ages. Research from the Centers for Disease Control has found that younger populations do get infected by COVID-19 and some severe outcomes have been reported in younger populations, albeit fewer per capita. It is also important to note that individuals with a mild or even asymptomatic case of COVID-19 can spread the infection to others who may be far more vulnerable and may have pre-existing health conditions that may result in hospitalization or even death (obesity, high blood pressure, diabetes, asthma, etc). While it is not possible to eliminate all risk of furthering the spread of COVID-19, the current science suggests there are many steps that we can take to reduce the risks to prospects, coaches, and their families.

Alvin Parker Football Camps LLC will take the necessary precautions and recommendations from the federal, state, and local governments, CDC, as well as the VADOH. Alvin Parker Football Camps LLC realizes that the knowledge regarding COVID-19 is constantly changing as new information and treatments become available. These recommendations will be adjusted as needed as new information becomes available in order to decrease the risk of exposure for our staff and prospects.

These Recommendations include but may not be limited to:

1. Promoting healthy hygiene practices such as hand washing, using hand sanitizer, cough in your elbow, avoid touching eyes, nose, face and mouth, no spitting, no gum chewing.
2. No handshakes/celebrations (high fives, fist/elbow bumps, chest bumps, hugging)
3. Encouraging social distancing through increased spacing, small groups, and limited mixing between groups, where feasible
4. Educating prospects, coaches, and staff on health and safety protocols
5. Requiring anyone who has COVID-19 related symptoms to stay home and not attend the camp
6. Requiring anyone who presents with COVID-19 related symptoms at check-in or is sick to stay home until further instructed by a health care professional.
7. Requiring all prospects and coaches to provide their own water bottle for hydration. Water bottles must not be shared.
8. PPE (i.e. masks) will be required to be worn at all times where feasible.

I understand that participating in athletic camps, events, and activities may include a possible exposure to COVID-19. While particular recommendations and personal discipline may reduce the risk of infection, the risk of serious illness and death still exists.

I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of others, and assume full responsibility for my participation. I willingly agree to comply with the stated recommendations put forth by Alvin Parker Football Camps LLC, the CDC, and the VADOH to limit the exposure and spread of COVID-19 and other communicable diseases.

I knowingly and freely acknowledge that if I am experiencing symptoms related to COVID-19, or have been in contact with an individual who has experienced symptoms related to COVID-19 within the past 14-days, or have been in contact with an individual who has tested positive for COVID-19 within the past 14-days, I will not attend the camp.

I knowingly and freely acknowledge that if I willingly do not report the above mentioned conditions to the camp staff and attend/participate in the camp by intentionally violating the aforementioned statements regarding COVID-19, that I will waive my right to legal action brought forth to Alvin Parker Football Camps LLC. Furthermore, I will also be subject to legal action taken by Alvin Parker Football Camps LLC and other individuals who may have been affected by potential exposure to COVID-19.

I knowingly and freely accept that if I violate any of the terms and conditions set forth by this document, at any time, that I am subject to immediate dismissal from the camp with no refund.
